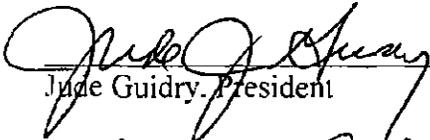

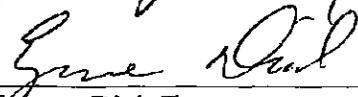

Internal Controls

Receipt and Processing of Funds Received:

All funds received are handled by a member who processes the payment/receipt of funds and issues a letter (receipt) to the individual or corporation that made the donation to PRO-NSU stating the purpose of the donation, value of the donation and the organizations 501(c)(3) IRS status. This member properly logs payment of dues under each member's computer file name. The funds are deposited in the checking account. The deposit receipt and correspondence received is then provided to the treasurer who verifies the deposit and documentation of receipt of funds.

Expenditure of Funds:

The Board of Directors reviews and approves yearly expenditures, that is, campus events and activities which PRO-NSU has long term sponsorship relationships. Expenditure requests received between meetings require the approval of the PRO-NSU president. All expenditures are made by check. PRO-NSU does not have any paid employees and makes no payment of funds to any university employee for work done on behalf of PRO-NSU.

Compliance with State and Federal Requirements

PRO-NSU is current with State and Federal reporting requirements. The annual report and filing fee required by the Secretary of State for the State of Louisiana for 2010 was submitted December 1, 2010. PRO-NSU filed Form 990-N for 2010 with the Internal Revenue Service on 2/1/2011 (see attached copy of electronic receipt).
